The following are the conditions of entry and rules of the event. Please read this carefully and ensure you fully understand all of the items below before signing and submitting the entry form.

1. Each participant will be expected to complete the entire distance within the given timetable.
2. Each participant must stay on the approved route

3. Participants must not antagonise motorists or pedestrians and must obey the Highway Code / appropriate Traffic Laws and Regulations at all times
4. The 2021 event will commence in St Tropez at 8am on the 3<sup>rd</sup> October 2021 and finish in Monte Carlo that same day.
5. For insurance and safety purposes, the required minimum age of all participants is 18 years as of 3<sup>rd</sup> October 2021. Participants must be personally covered under the Insurance Scheme organised through the Union Cycliste de Monaco and Federation Monegasque de Cyclisme. The application forms for this accompany this entry form.
6. It is recommended that participants from overseas in particular should also ensure that they are further personally covered for travel, health, accident and loss of equipment as well as obtaining a European Health Insurance Card prior to the event if appropriate. This is the responsibility of participants individually and in no circumstance will there be any liability arising from failure to do to the event organisers, The COCC, or its officials.
7. This entry form, the relevant Union Cycliste de Monaco and Federation Monegasque de Cyclisme forms, plus the €1000 inclusive entry fee which includes the insurance cover, kit and one party invitation, must all be received before any entry may be accepted.
8. You agree that the personal information relating to you can be stored, used by us and any event partners in connection with the organisation, staging and administration of the event.
9. You warrant to us that you will be on the event date, sufficiently fit and healthy to participate in the Event unaided and in accordance with the Agreement, if you are in any doubt we recommend that you seek medical advice.
10. You must inform us immediately if you need to withdraw for any reason. If you do so your fee will not be returned but entirely at the discretion of the event organisers, may be permitted to hold over for a guaranteed place next year.
11. Each participant will receive a set of commemorative kit which should be worn on the day unless the participant is legally and contractually precluded from so doing by reason of profession or other activities.
12. Participants must make their own way to and from the event start and finish positions although the event organisers, The Champagne and Oyster Cycling Club of Monaco (The COCC's) may provide a limited free service to transport cycles to St Tropez on Saturday 2<sup>nd</sup> October 2021. Participants using this free service accept that this is entirely at their own risk and are responsible for being at the nominated pick up point at the appointed time to collect them.
13. In no event shall we be liable to you whether for breach of contract, any tortious act or omission including negligence or otherwise under or in connection with the Agreement for any a) loss or damage b) loss of profit c) loss of reputation d) loss of business, revenue or goodwill e) loss of anticipated savings f) pledges made on your behalf or by you to charity or g) consequential or indirect loss, regardless of whether the loss or damage i) would arise in the ordinary course of events i i) is reasonably foreseeable or i i i) is in the

contemplation of the parties or otherwise. Nothing in this agreement shall affect our liability for death or personal injury, fraud or any other liability to the extent it cannot be excluded or limited by law.

14. This Agreement shall be governed by Monaco Law and the parties submit to the exclusive jurisdiction of the Monaco Courts. If any provision of this Agreement is invalid or unenforceable, in whole or in part, the validity of the remainder shall not be affected. The Agreement does not create, confer or purport to confer any benefit or right enforceable by any person not party to it.
