Cycle with the Champions - Terms and Conditions

"The event organisers" and "the charity" Caudwell Children* proudly present "the challenge" Cassis to Monaco raising funds for Caudwell Children*

Costs and Fundraising Commitment

- I understand that the charity is liable for the event costs and my deposit covers these costs alone. I agree to pay €550/£500 deposit on signing up for the challenge which is non-refundable.
- I agree to raise a minimum of €3000/£2500 for Caudwell Children through my personal sponsorship and fundraising activities. 80% must be raised 8 weeks prior to the challenge and the remaining 20% within 4 weeks after the challenge.

Participant Terms and Conditions

- I understand that I participate /cycle in this challenge completely at my own risk and that the charity will not be held responsible for any damage, injury or loss however caused by me outside of the third party insurance in place for the duration of the event.
- Cyclists are responsible for taking out their own third party insurance.
- I agree to wear a safety approved cycling helmet complying with the latest SNELL standards for the duration of the challenge.
- Entry fees are non-refundable.
- By signing in agreement of the terms and conditions I declare myself medically fit and able to participate in the challenge. By entering the challenge, I waive any liability on the part of the event organiser due to medical grounds.
- The event organisers have designed this event to be a serious challenge. You agree to ensure you have completed sufficient training and preparation to ensure you are appropriately prepared to undertake the challenge.

Regulations and Conditions of the Event

As a participant in the Cycle with the Champions cycle, you agree to participate in the challenge along the regulations and conditions outlined.

- Participants agree to undertake sufficient training ahead of the challenge.
- Participants are responsible for ensuring their bike is suitable for the challenge and riders will be responsible for the road worthiness of their own cycle at all times.
- It is mandatory that all riders wear a safety-approved cycling helmet, any riders not wearing a helmet will not be covered by the event insurance and will be disqualified from the event and could be liable for damages if involved in an accident on that basis. The rider must accept this as a condition of their participation.
- Participants must be over 18 years of age on the day of first stage of the event.
- Tri-bars are acceptable; however they are not to be used in group riding.
- Riders will set off in groups of 20 or less at intervals of no less than 2 mins but start times are flexible.
- You must obey the road rules of Italy and France. You are requested to ride in single file where appropriate and
 no more than 2 abreast at any time. Please be aware of your fellow cyclists and any other traffic. Please always
 indicate your intention to stop or change direction. All cyclists must adhere to and obey the laws of France &
 Italy where applicable and extend all reasonable courtesy to other road users.
- Cyclists must act appropriately at all times during the event given that during this event you are representing Caudwell Children charity.
- You may not deviate from the official route. It is the responsibility of all riders to take the correct route.
- Please do not use your mobile phone when riding and if taking or making calls please do it safely at the side of the road.
- The organisers reserve the right to terminate an individual's ride on health and safety grounds.
- The rides will take place regardless of bad weather and will only be cancelled, rerouted or stopped for reasons of safety. Entry fees and sponsorship are non-refundable.
- The support team will endeavour to provide fluid and food at designated rest stops, however supplies are not guaranteed and riders are encouraged to only take what they need and be mindful of those following behind.
- No rider may take food or drink from anyone whilst on the move. Riders agree to stop to receive food or drink from other persons.
- Individual support cars are strictly forbidden, any participants seen to use one will be taken out of the event and not covered by the event third party insurance.

- All riders are encouraged to carry the following at all times:
 - A form of identification with name, address and contact information for their next of kin / person to be contacted in the case of an accident.
 - 2 drinks bottles
 - Energy bars
 - Bike tools, replacement inner tubes and a working pump
 - Appropriate clothing considering the route and weather conditions
 - Money and mobile phone
 - Suitable Lights

Event Insurance

Riders are covered by the event's third party public liability insurance for the duration of the event. Individuals are also responsible for organising their own third party insurance.

Your bike and / or personal possessions are not covered by the event insurance or charity's insurance. Personal possession and bike insurance is at own discretion and own cost.

Participants must put in place their own travel insurance and agree to provide a copy to Caudwell Children. This is at your own cost.

Caudwell Children are the event organisers of the Cycle with the Champions event.

Caudwell Children are the beneficiary charity for funds raised from participants in this event.
